The Litecoin is stored with BitGo Trust Company, a secure, regulated custodian, built for digital assets. Strict KYC and AML standards ensure the provenance of all custodied cryptocurrency is vetted.

Fund Objectives

ETC Group Physical Litecoin (ELTC) is an exchange traded cryptocurrency (ETC) that tracks the price of Litecoin. ELTC's primary listing is on Deutsche Börse's XETRA and it is centrally cleared, providing investors with a secure and liquid way to gain exposure to the Litecoin cryptocurrency. Each unit of ELTC is 100% physically backed and gives the holder a claim on a predefined amount of Litecoin. ELTC is issued by ETC Group and distributed by HANetf.

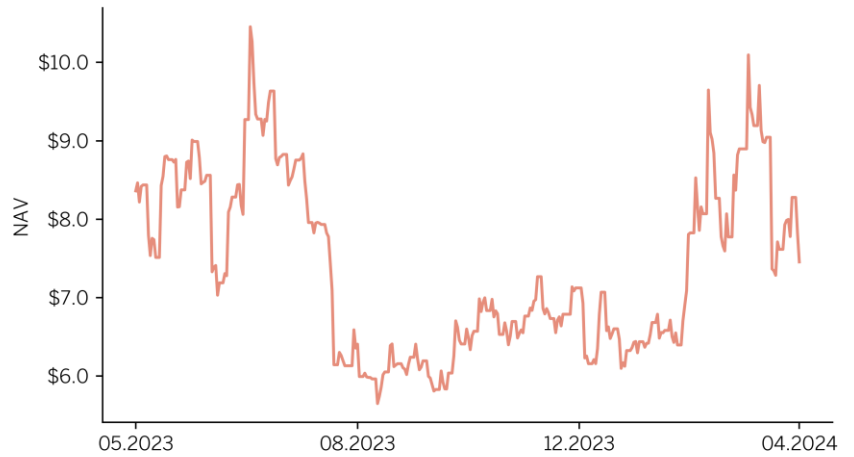
